## **Correspondence from Ger O’Dea Community Engagement Manager – National Ambulance Service**

There are a few details mentioned in Ger’s correspondence that we wish to bring to highlight.

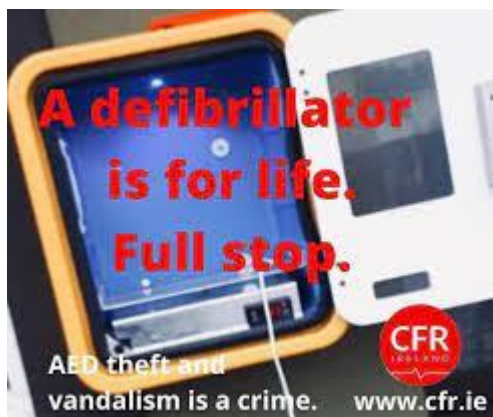
1. *“There are now 137 CFR resources on the system with over 1000 calls responded to since December 2020 and since December 2021 over 200 CFR enhanced calls were also responded to”.*
  - (i) If you take it that 135 CFR resources is about half the pre-pandemic resources.
  - (ii) Within those groups, anecdotal evidence tells us that there is circa 50% of those group members reactivated.
  - (iii) The OHCA Report 2020 informs us that the EMS attended 2,638 cardiac arrests. It would be fair to say the between December 2020 and December 2021, CFRs will have attended between 35% and 40% of all cardiac arrest calls nationally.
  - (iv) That is phenomenal. Well done all.

2. The National Ambulance were able to extract this information because CFRs are using the communication procedure (TEXT Back). It is NAS Policy and imperative that CFRs use the TEXT Back procedure. So NEOC can inform the persons on scene that there is a CFR on the way, in case the clinical requirements on scene exceed the CPGs of a Community First Responder, for CFR safety and to inform national data collection.
3. There is a new “Online” incident feedback form. (This does not replace the CFR Patient Report Form, CFRs must complete it too). This new incident feedback form can be accessed by clicking [FILL OUT FORM](#) . Though it is not mandatory it is very important that every CFRs that attended an emergency call makes an effort to complete this “Online” form.

# **Community first response and out-of-hospital cardiac arrest: Identifying priorities for data collection, analysis, and use via the nominal group technique. *Resuscitation Plus 9 (2 0 2 2)***

Key stakeholders (e.g., CFR volunteers, clinicians, EMS personnel, cardiac arrest survivors/their relatives from across Ireland) were canvassed to be part of a nominal group technique (NGT) to explore data gathering by, for and of Community First Responders.

The nominal group technique (NGT) is a structured process where key stakeholders develop and decide on a set of prioritised recommendations. This study employed the NGT, using an online survey and online consensus meeting, to identify:

- 1. The most important CFR data to record and analyse and*
- 2. The most important uses of CFR data*

The top priorities were selected during the consensus meeting. Stakeholders were provided with a list of responses from the online survey for each topic and voted on what they considered to be the top 10 priorities for each. **Table 3** in the paper shows the top 10 responses for each topic.

For example, the top response voted by the stakeholders for Topic 1 – The most important CFR data to record and analyse, was “**What was the response time of the CFR volunteer?**”

The top response voted by the stakeholders for Topic 2 – The most important uses of CFR data, was “**To provide feedback to CFR volunteers**”

These results help us to identify and understand what information is important to collect during CFR activities and the best way to use this information to improve the CFR service.
